SERVES CRITICAL ROLE

he Environmental Quality Board (EQB) is a group of 13 citizen members who serve as the Agency's rulemaking authority. The Governor, with Senate confirmation, appoints each member to represent legislatively prescribed categories of DEQ customers. These 13 individuals take time from their own busy professional lives to serve in this extremely important role.

The EQB reviews and considers rules recommended by each of the eight advisory councils. The Board's action is the final step before a rule is sent for consideration by the legislature and ultimately the Governor.

The Board conducts quarterly meetings and holds statutorily required public forums in con-

junction with those meetings. Last year these meetings were held in Durant, Hooker, Norman, and Weatherford.

During FY 2001 a new Board member Mr. Steve Mason, was appointed to replace Cheryl Cohenour. Each member serves staggered terms and may be re-appointed to subsequent terms.


